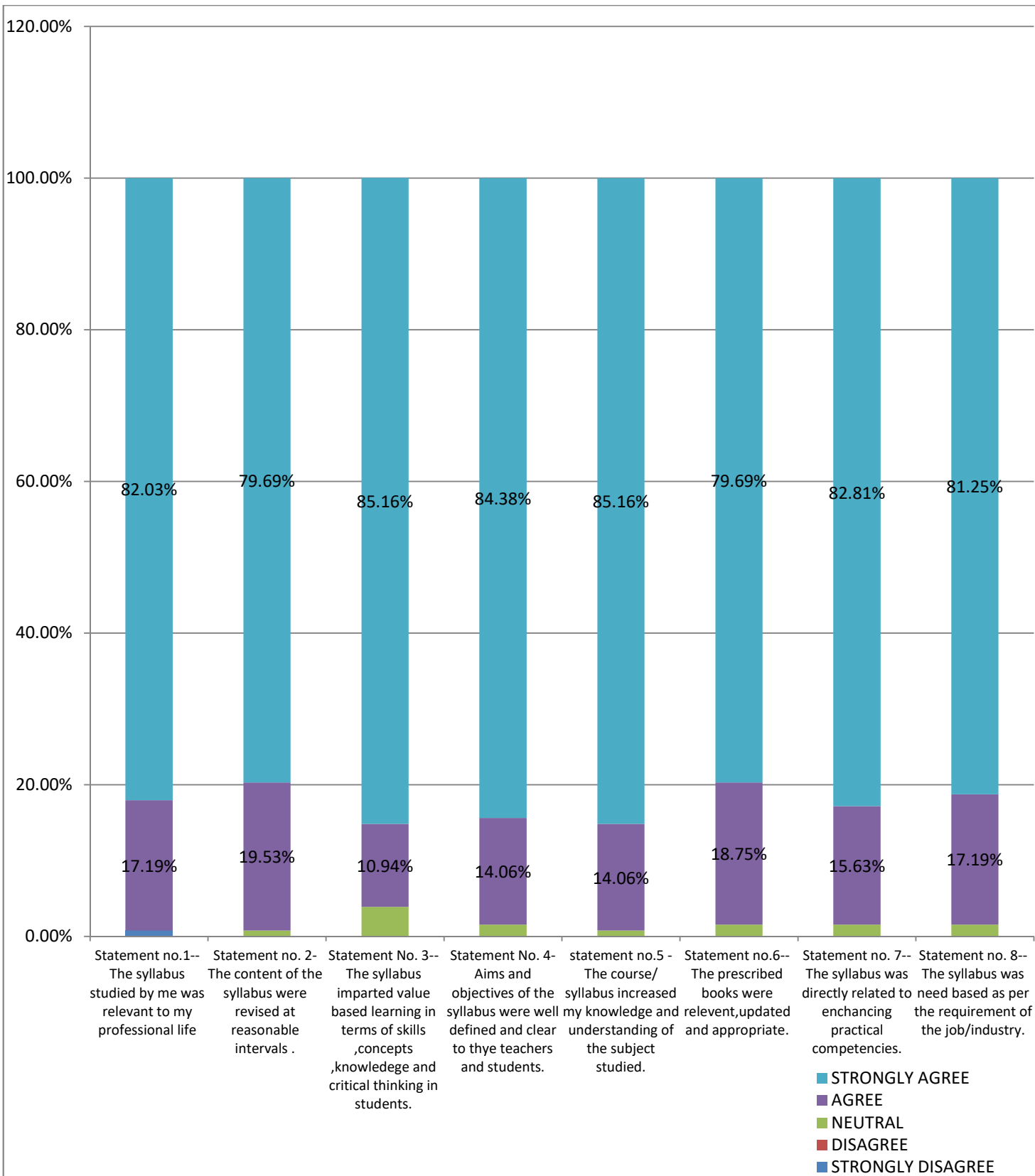

# Alumni feedback Analysis Report

## Session (2023-24)

- 1. Relevance to Professional Life:** An overwhelming 99.22% of respondents either agreed or strongly agreed that the syllabus was directly relevant to their professional life. This demonstrates that the curriculum effectively meets the career-oriented needs of students.
- 2. Timely Revisions:** Similarly, 99.22% of students felt that the syllabus was revised at reasonable intervals, reflecting that the institution is proactive in keeping the content current and aligned with industry and academic standards.
- 3. Value-Based Learning:** A majority of 96.10% of respondents recognized that the syllabus imparted essential skills, knowledge, and critical thinking abilities, highlighting the curriculum's capacity to promote comprehensive, value-based learning that goes beyond rote knowledge.
- 4. Clear Objectives:** A significant 98.44% of students agreed that the aims and objectives of the syllabus were well-defined and clear to both teachers and students. This clarity ensures that there is a shared understanding of the course's goals and expectations, facilitating a more focused and effective learning process.
- 5. Increased Knowledge and Understanding:** Nearly all respondents (99.22%) agreed that the syllabus helped increase their knowledge and understanding of the subject, confirming the course content's depth and its role in enriching students' academic comprehension.
- 6. Prescribed Books:** In terms of resources, 98.44% of students felt that the prescribed books were relevant, updated, and appropriate for the course, though a small 1.56% rated this aspect as neutral, indicating some potential room for improvement in updating course materials.
- 7. Practical Competencies:** A total of 98.44% of respondents agreed that the syllabus was directly related to enhancing their practical competencies, reflecting that the curriculum successfully integrates hands-on learning experiences that are essential for professional skill development.
- 8. Industry and Job Relevance:** Likewise, 98.44% of respondents felt that the syllabus was need-based and aligned with the requirements of the job market or industry, confirming its applicability in preparing students for real-world challenges.

**Summary:** The feedback underscores a high level of satisfaction with the syllabus. Students find the course content relevant, up-to-date, and aligned with both academic and professional needs. Minor improvements could be made in ensuring all prescribed resources are as up-to-date as possible, but overall, the syllabus is seen as comprehensive, practical, and well-organized to support student success in their professional careers.

1. **Relevance to Professional Life:** Since 99.22% of respondents affirmed that the syllabus was relevant to their professional life, we are committed to maintaining the strong alignment between academic content and real-world applications. 2. **Timely Syllabus Revisions:** With 99.22% of respondents satisfied with the timely revision of the syllabus, we will continue our regular review process. A formal review committee has been established to monitor academic advancements and revise the syllabus as needed, ensuring it remains aligned with both industry demands and academic excellence.
3. **Value-Based Learning:** As 96.10% of alumni recognized the value-based learning provided through the syllabus, we plan to further enhance this aspect by introducing new modules that focus on interdisciplinary learning, soft skills, and ethical decision-making. These updates will aim to deepen students' critical thinking and problem-solving abilities.
4. **Clear Objectives:** Since 98.44% of respondents agreed that the syllabus objectives were clear to both teachers and students, we will continue to ensure that all learning goals are well-communicated. Faculty will receive updated training on clearly defining and conveying course outcomes, so students remain aligned with the program's educational objectives from the start.
5. **Increased Knowledge and Understanding:** With 99.22% of respondents agreeing that the syllabus increased their knowledge and understanding, we plan to reinforce this by integrating more advanced case studies, guest lectures from industry professionals, and opportunities for research-based learning. These additions will ensure students stay engaged with in-depth, practical knowledge.
6. **Prescribed Books and Resources:** Given that 98.44% of students found the prescribed books relevant and updated, we are working to ensure that any outdated or less relevant materials are replaced with the latest editions. We are also exploring partnerships with publishers to provide more e-books and access to updated academic databases to further enrich student resources.
7. **Enhancing Practical Competencies:** Recognizing that 98.44% of respondents were satisfied with how the syllabus enhanced their practical competencies, we are introducing additional hands-on projects, internships, and practical workshops. These initiatives will be designed to further strengthen students' job-ready skills and ensure they can confidently apply theoretical knowledge in professional settings.
8. **Job and Industry Relevance:** With 98.44% of alumni agreeing that the syllabus was well-aligned with job market requirements, we will continue our practice of consulting with industry experts when revising the syllabus. Regular feedback sessions with industry professionals will be conducted to ensure that the curriculum remains responsive to current job market trends and employer expectations.
